Family Involvement Self-Assessment

- Marisol has used this form several times, and loves it. Sent it into office to
 consider using with stakeholder workgroups. Feels her state is not training
 parents to understand what the purpose of the workgroup is. Creating a
 new website. Would like to have a section on the website for family
 involvement with form like this and some orientations for families joining
 the workgroup.
- Time commitment: meeting time and preparation time; "Is this a term commitment? If so, how long is the commitment? Or ongoing?"
- Kathleen: Every state system is different: "Do you understand if or how the reimbursement may impact any state or federal benefits that your family may be receiving? (Medicaid, SSI, etc.)"
- Darla will reach out to Family Voices and others to get the wording right.
- Sadia: Could add "Do I have an additional opportunity during the meeting(s) to understand what the opportunity is so I can know what we're doing? What websites or individuals to gain more knowledge? Is there a mentor or guide?"
- Could add "Is there an opportunity to connect with other family members who have had this experience?" Covered under "Are other families involved?"
- Will this opportunity impact your current commitments? (Am I taking on too much?)
- Involving Families in a CSPD "The Basics"
- Marisol: helpful for state agencies making it look simple 5 easy basic steps – otherwise, they won't follow through. #5 is the most crucial – having a mentor to fill in the holes.
- No other comments.
- Self-Assessment for Administrators
- Kathleen: Form is beneficial for administrators who have a lot on their
 plates and don't have time to handhold a mentor would provide them a
 reminder to engage with new family participants.
- Marisol: in her state, ICC members are not allowed to discuss ICC business outside of a meeting. Parent felt lost and did not get adequate support.
 Darla indicated that the field has been advocating for PTI's to have a seat on the ICC for that specific reason. Staff person assigned to mentor needs to be more involved.
- <u>Involving Families in State Systems of PD</u> Darla reviewed the guide and asked participants to review it and send feedback directly to her.
